MANAGEMENT:

Sree Narayana College of Education at Mahe, affiliated to Pondicherry Central University & Recognised by NCTE was established in the year 1995. The college is managed by Sree Narayana Educational Guidance Society at Thalassery, which is a charitable society registered in the year 1987. The prime aim of the society is to promote professional education to the backward class of the community especially those who are educationally and socially disadvantaged. Dr. M.A.Sundaram, a well known physician and philosopher of Thalassery was the Chairman of the college for a very long period. He was succeeded by Dr. N.K. Ramakrishnan, the founder Principal of the college as Chairman. The college has successfully completed 26 years of academic excellence offering B.Ed Degree Course under Pondicherry University. So far the college has produced 3000 successful teachers. Majority of them are working as teachers in different parts of our country.

THE COLLEGE:

The college is approved by Govt. of Puducherry, recognized by N.C.T.E, the statutory body at National level, and affiliated to Pondicherry Central University. It was established in the year 1995. The B.Ed. Degree awarded by Pondicherry Central University is recognized by all other Universities as well as Kerala P.S.C and U.P.S.C.



BUILDING & INFRASTRUCTURE:

The society has constructed a 04 storey classic building of its own including the ground floor of the college in the year 2004 at the heart of Mahe Municipality. It is purely designed in accordance with the guidelines of the N.C.T.E. Seven (07) optional Class rooms, two Lecture Halls, Seminar Hall and a spacious well designed Auditorium. Separate Laboratories for Science subjects, Psychology and Educational Technology etc. are systematically provided. A spacious Library cum Reading room and a room for work experience are also arranged in the ground floor of the college building.

TEACHING FACULTY:

The institution provides the services of a highly competent team of committed teachers to meet the academic requirements of the present scenario. Their appointments are made as per the norms of the University and NCTE.

GENERAL LIBRARY:



Our College General Library has a huge collection of standard books consisting Reference books, Encyclopedia and books on various subjects like Education and Curriculum, Health and Child Development, Educational Technologies Journals/ Magazines, News Papers etc. In order to promote Research, both for Faculty & Students photocopying and printing facilities are provided, subject to copy right restrictions.

AUDITORIUM:

At the top floor an auditorium is constructed on one side with a seating capacity of 400 students and a Seminar Hall is also provided at the adjacent side.

**COMPUTER LAB:**

A highly innovative air Conditioned Computer Lab consisting Laptops and Desktops have been arranged in the first floor of the building. A high speed Broadband Internet Connection is also provided., All systems are systematically arranged.

LABORATORIES:

Laboratories are arranged separately for Physical Science and Biological Science. The essential materials required for conducting experiments upto 12th class is provided in the Lab. Various models, specimens, equipments, chemicals and charts related to each branch is well arranged. The details are furnished separately

**DURATION OF THE COURSE:**

- a) The programme of study shall be for a duration of two academic years.
- b) There shall be at least 200 working days each year exclusive of the period of examination and admission process.

INTAKE:

As per the revised policy of NCTE our intake capacity is fixed to 100 students (02 units of 50 each).

ADMISSION CRITERIA AND ELIGIBILITY FOR ADMISSION:

Admission to the B.Ed. Course is open to all those who fulfill the eligibility criteria. The selection list is prepared in accordance with the guidelines issued by the Admission Committee appointed by the Govt. of Puducherry. The selection list is prepared on merit basis which is subject to the approval of the University.

- a) A candidate shall be eligible for the admission to two year Bachelor's Degree programme in Education [B.Ed. (Non-semester)] provided that he/she should have passed the three years Bachelor's Degree Course under 11+1+3 or 10+2+3 pattern of study or Five years Integrated Master's Degree Course under 10+2+5 pattern of study and majored in any one of the subjects related to a school subject offered at the Secondary / Senior or higher Secondary education level (OR) four years Bachelor's Degree programme in Engineering / Technology under 11+1+4 or 10+2+4 pattern of study [with Mathematics and Science in both higher secondary and Engineering /Technology degree programmes]
- b) The candidates should have scored a minimum of 50% marks in Part-III (Main + Allied) of the Bachelor's degree programme. In case they have not scored this minimum they should have scored a minimum of 50% marks at the Master's degree level in the same subjects majored. The candidates belonging to SC, ST, MBC, OBC and PWD categories should have scored a minimum of 40% marks instead of 50% (as per the Government Order, UT of Puducherry).
- c) Engineering or Technology candidates should have specialized in science and mathematics with 55% of marks or other qualification equivalent thereto. Such candidates belonging to SC, ST categories should have scored a minimum of 50% marks.
- d) The major subject chosen at both Bachelor's Degree and Master's Degree should be the same, in case of students who are admitted based on Master's degree subject.
- e) The reservation for different categories should be as per the Government norms.
- f) The candidates who have taken more than one School subject as Main (Double or Triple Major) in the Bachelor's Degree will be eligible for admission to only one of the school subjects chosen.
- g) The candidates who have passed the Bachelor's degree examination in Open University System without qualifying in 10+2 or 11+1 pattern of school education examination shall not be considered for admission.
- h) There is no upper age limit for admission to two year B.Ed. programme.
- i) The medium of instruction shall be English.

FEES:

The tuition Fee per candidate is fixed by the Committee appointed by the Govt. of Puducherry. The revision of fees is effected in every three years as per the government decision.

GOVERNING BODY:

The college has a Governing Body of Educational experts including two University Nominees so as to promote the potential requirements to meet the challenges and attain the highest reputation. Dr. P. Bhaskaran Nair, Associate Professor of English (Rtd.), Pondicherry University is officiating as the Chairman of the College Governing Body.

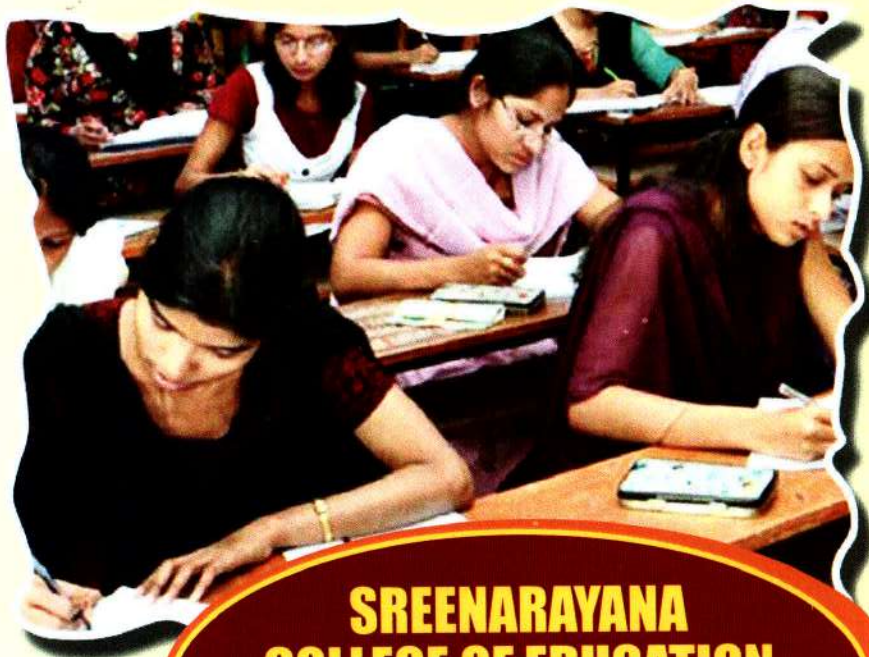
PASSING MINIMUM :

- Every student teacher should register for all the courses in the theory examination and practical examination in the first attempt.
- A student teacher shall be declared to have passed in the B.Ed. Degree examination only if he/she has passed both the theory and practical examination.
- A student teacher shall be declared to have passed in the theory examination if he/she obtains a minimum of 45% marks both in External Examination (36 out of 80) and CCE (9 out of 20) and a total of 50 marks by combining both external (EE) and internal (CCE) examination in each full course. In the case of half course, a minimum of 45% marks both in External Examination (18 out of 40) and CCE (5 out of 10) and a total of 25 marks by combining both external (EE) and internal (CCE) examination
- A student teacher shall be declared to have passed the practical examination if he/she obtains a minimum of 45% marks in the pedagogical subject and in each of other aspects of practical examination mentioned above and 50% marks by combining all the aspects taken together.
- A student teacher who fails in one or more courses in the theory examination shall reappear in those course(s). But the one who fails in any one of the aspects of the practical examination shall reappear for all aspects.
- The B.Ed. Degree programme should be completed by the student teachers in not more than 4 years from the date of admission to the programme.

CLASSIFICATION OF SUCCESSFUL CANDIDATES:

All successful student teachers shall be classified as follows:

Examination (out of 2000 marks)	Class to be awarded
1200 and above	FIRST CLASS (≥ 60% of Grand Total)
1000 to 1199	SECOND CLASS (≥ 50% to < 60% of Grand Total)
